At the opening of the meeting, the Chair welcomed Dave Wright, retiring Clerk to the Authority.

The Chief Executive & Chief Fire Officer addressed the Authority in relation to the additional urgent item on the Agenda, concerning the Merseyside Fire Brigades Union response to Merseyside Fire & Rescue Services Integrated Risk Management Plan 2010-13, and requested Members for permission to withdraw Agenda Item 10 – Crewing Of Fire Appliances, in order to consider the feedback contained within the FBU response. The Report will be brought back to a future meeting of the full Authority.

The Chief Executive & Chief Fire Officer also provided Members with an update regarding the successful prosecution of an individual following a fire within the Liverpool District. The successful prosecution was the result of great efforts by the Service's Incident Investigation Team and great acts of bravery at the scene.
