Purpose of Report

1. To request that Members note the recommendations of this report relating to fatalities occurring in accidental dwelling fires during the financial year 2012/13. The report also provides a historical analysis of fatality data, providing information based on trends that can be used for future planning and resource allocation.

Introduction & Background

3. The purpose of this report is to provide information regarding fatalities in accidental dwelling fires for 2012/13 and also over a nine year period. The reports (appendices A and B) provide detail regarding the demographic properties of victims, the circumstances of the fatality as well as providing further background

- information about factors such as deprivation and social conditions. Full details are contained in the two reports attached as appendices.
- 4. The reports will be used by the Prevention and Protection Function to develop actions for the future to target areas and individuals at higher risk and put arrangements in place to reduce that risk and protect vulnerable people. This includes sharing information about vulnerable people with partners and the attached reports can be used to explain to partners why that MFRA having access to that information is important.

5. The reports identify that younger people in more deprived areas and older people in more affluent areas are at more risk of dying in an accidental dwelling fire. The use of the Customer Insight Vulnerability Index that is being developed by MFRA and LJMU will assist in more effective targeting of these individuals.
