### **Purpose of Report**

1. To inform Members of the changes to the membership of the Authority for 2026/27.

### **Recommendation**

2. It is recommended that Members:

  - b) note the continued appointment of the Police and Crime Commissioner (PCC) for Merseyside to the Authority; and
  - c) approve the continued role of Co-opted Member and for the Co-opted Member to continue to be appointed to both the Audit Committee and Scrutiny Committee, as a non-voting member (subject to approval of the structure).

### **Introduction and Background**

3. The appointments of Councillors Jeanette Banks, Jeanie Bell from St Helens Council, Doreen Knight from Liverpool City Council, Graham McManus, Mike Sullivan, Lesley Rennie from Wirral Council and Edna Finneran from Knowsley Council ended as a result of local elections or a change to appointments made by their respective district councils.

5. The political balance of the Authority for this year is 61.11% Labour, 11.11% Liberal Democrat, 11.11% Reform UK, 5.56% Conservative, 5.56% Green Party and 5.56 % for Your Party Liverpool. Political balance issues are considered in a separate report relating to the structure of the Authority, which is also presented for consideration at this meeting.
6. At the Annual General Meeting on the 10th June 2021, it was agreed that the PCC for Merseyside be appointed to the Committee with full voting rights. It is recommended that this appointment continues.
7. The Authority has previously had a Co-opted Member, Mr Anthony Boyle appointed to the Scrutiny and Audit Committee as a non-voting Member to provide additional independent scrutiny.
