ONS data on age/ethnicity/ Knowsley Resilience Monitor The 2011 Census of England & Wales counted population as at 27 March. At this point the population of the Borough was 145,893.

During the planning meeting it was recognised that Knowsley has a small BME community (approx. 2.8% - compared to 14.1% in England & Wales).

The demographic breakdown of the district shows those aged 16-25 years form approximately 12.1% of the Knowsley population.

English Indices of Multiple Deprivation 2010. Department of Health – Health Profiles provide ward and populous data sets on key health outcomes. Knowsley is the fifth most deprived borough in England and has high levels and concentrations of deprivation, poor health and low attainment. Large numbers of people in the borough depend on benefits, particularly incapacity benefit. Almost 30% of homes are social housing.

MFRS Strategy Performance Internal reports highlight - ASB fires happen at specific times and that certain areas are more susceptible to ASB fires than other areas.

We use sophisticated information tools to identify and analysis data pertinent to the vulnerable community of Knowsley.

Road Safety Data from Knowsley Road Safety Team

- Reduction in number of Deliberate Secondary Fires during 2014.
- > Slight increase in the number of incident during the Bonfire Period.
- Accidental Dwelling Fires continues to be a challenge, however in comparison to 2013 we estimate a reduction of approx. 21.4%.
- ➤ Data highlighted those aged between 16 25 are disproportionately involved in RTC across the Borough.

RTC's across the borough have reduced year on year since 2012/13 we estimate a slighty reduction again this year.

Governments Strategy on independent living

This information is used to support our risk reduction activities in the District and Station Action Plans.

There are currently government strategies in place to support the elderly and vulnerable to continue to live in their own home with suitable assistance.

The creation of a Knowsley "healthy homes" team will deliver significant benefits to the fire service and key partners operating in Knowsley – it will help focus the efforts of front line responders to view the property holistically when devising risk reduction strategies, in the first 4 months the team have knocked on over 5500 doors, completed near to 500 surveys which in turn generated over 1380 referrals.

Key findings from Knowsley Resilience Monitor – this is produced every quarter and informs partners.

During 2014/15 the Safer Knowsley Partnership will have a concerted multi agency approach to the Hillside Estate; this will see engagement across all groups.

We currently deliver Fire Fit in 3 Knowsley Primary Schools it is our ambition to extend to 6 schools during 2014/15.

Meetings held in January 2015 with internal staff, partner agencies, Local Authority, Elected Members, community organisations The Knowsley district identified a number of priorities which derived from a series of station planning meetings. The priorities identified from the meetings were then used as a catalyst during the station and local service planning meetings to reflect the relevant Merseyside Fire & Rescue Services priorities;

Use of snap survey and on line questionnaires to capture responses.

- To reduce accidental dwelling fires and the deaths and injuries which result from these fires in Merseyside
- To reduce risk consistently across Merseyside
- To reduce the impact of fire on commercial enterprise

and the wider community

 To reinforce our role in fire prevention by improving fire safety within the public and commercial buildings of Merseyside

This is particularly prevelant at this time in terms of minimising the impact of fire to the business community and supporting economic stability and regeneration.

This is in addition to other key consultation exercises undertaken throughout the year such as Bonfire Planning.

6. Conclusions

(a) Age

The District Management Team, Prevention Team and Operational Crews are working with the Knowsley Road Safety Management Team in order to make an impact on reducing the number of road traffic collisions in those aged 16-25 years which forms 12.1% of the Knowsley population.

We are currently delivering Fire Fit in 3 Knowsley primary schools and are working towards establishing the project in 3 more schools.

(b) Disability including mental, physical and sensory conditions)

13.4% of the population of Knowsley are registered as having a disability. The Prevention Team look to empower people disabled people and the wider community so everyone can enjoy life equally. They do this by providing advice and issuing equipment i.e. fire retardant bedding packs to reduce the risk of fire death or injury. We actively look to engage with the disabled community through the use of Community Messaging, by providing this method of communication we can provide a service to those hard to reach due to social isolation or refusal to accept services. FSN are engaged in delivering a disability sport programme in Huyton.

(c) Race (include: nationality, national or ethnic origin and/or colour)

Knowsley has a small BME community (2.8%) However our actions are broad enough to ensure we effectively target people who we have identified as being at risk. These challenges are reviewed quarterly by the Knowsley Resilience Group (MFRS chair this forum) along with other matters of community cohesion.

(d) Religion or Belief

There were no issues raised by our partners to suggest that religious orientation identified individuals as vulnerable. Our home fire safety strategy reflects a non-discriminatory approach to proactive community safety.

(e) Sex (include gender reassignment, marriage or civil partnership and pregnancy or maternity)

Domestic Violence is taken very seriously by the Safer Knowsley partnership and is one of the Key objectives in its business plan – MFRS will support joint working in this area.

As a Fire Service we take Hate Crime seriously. Through the Multi-Agency Risk Assessment Conferences (MARAC), Multi-Agency Public Protection Arrangements (MAPPA) procedures we share information with partner agencies.

(f) Sexual Orientation

As a service provider and employer, MFRS has an important leadership role in influencing others, promoting and encouraging fairness and equality and contributing to a more just and compassionate society. MFRS will work with all its citizens, partners, businesses, voluntary and community groups to develop a shared understanding and commitment to its objectives.

(g) Socio-economic disadvantage

Knowsley is the fifth most deprived borough in England and has high levels and concentrations of deprivation, poor health and low attainment. Large numbers of people in the borough depend on benefits, particularly incapacity benefit. Almost 30% of homes are social housing. Growth and Economic development have been considered in our plan, as has welfare reform – these challenges are reviewed quarterly by the Knowsley Resilience Group.
